

LITE LEAGUE CONTEST – Retail
OFFICIAL CONTEST RULES
(the “Rules”)

1. **CONTEST PERIOD AND ORGANIZER.** Lite League (the “Contest”) is organized and sponsored by Molson Canada 2005 (the “Sponsor” and the “Organizer”). The Contest begins on September 1st, 2025 at 12:01 a.m. Eastern Time (“ET”) and ends at 11:59:59 p.m. Eastern Time (“ET”) on February 10, 2026 (“Contest Close Date” or “Entry Deadline”) (together, the “Contest Period”). The clock used by the Sponsor will be the official clock to determine the date and time of receipt of an entry (as such term is defined below).
2. **ELIGIBILITY.** To be eligible to enter and win, this Contest is open to legal residents of Canada who are of legal drinking age and for the Grand Prize (defined below), you must be twenty-one (21) years of age or older at time of entry. You are not eligible to enter or win, if you are: a) an employee, representative or agent of Sponsor/Organizer its affiliates and related companies, advertising or promotional agencies, the contest judging organization, any participating locations or the prize suppliers; b) an employee or contractor of a provincial liquor authority, a beer distribution company or a participating licensed establishment, or, any liquor licensee authorized by a provincial liquor authority; c) anyone involved in the development and/or administration of the Contest; or d) a member of the immediate family (defined as parents, siblings, children and spouse, regardless of where they live) or household (whether related or not) of any of the above persons.
3. **AGREEMENT TO BE LEGALLY BOUND.** By entering this Contest, each entrant agrees to be bound by (i) these Rules; and (ii) all decisions of the Sponsor/Organizer, which are final in all respects.
4. **LITE LEAGUE WEBSITE.** To enter the Contest and be eligible to win a Prize (as such term is defined below), each entrant must: (i) go to liteleague.ca; and (ii) have or create an account.

To create an account, visit the Lite League website at liteleague.ca (the “Website”) and complete all the required information, namely, by providing your name, date of birth, email address, telephone number and postal code. All fields on the entry form must be completed unless they are otherwise indicated as optional. It is free of charge to create and obtain an account.

HOW TO PARTICIPATE.

During the Contest Period, once a participant has created an account, obtain a PIN card with a unique code by purchasing a specially marked case of Miller Lite while supplies last; and to those requesting PINs without product purchase (no purchase necessary) by email see Rule 6 below while supplies last.

NO PURCHASE NECESSARY:

To obtain a PIN without product purchase while supplies last, mail an original handwritten essay (75 word minimum) on the topic of “What is your favourite Football Team and why?” (the “Essay”) along with your name, date of birth and email address and mail to: Miller Lite® 2025/26 Lite League Contest, c/o Molson Coors Canada, Attention: Corporate Affairs Dept., 33 Carlingview Dr., Toronto, ON, M9W 5E4.

Upon receipt of the Essay, you will receive by e-mail one (1) PIN number. PIN will be sent directly to the e-mail address provided by the Essay writer. Requests must be received by no later than February 9th, 2026 for timely processing and return, and an entrant will have until September 4th, 2025 at 11:59pm (ET) to

enter and submit their PIN. Sponsor will not be held responsible if e-mail address provided is invalid, incorrect or missing at time of Essay submission and PIN request. Each request must be submitted by the entrant him/herself directly. Only original, legible Essays will be accepted, no duplicates or mechanical reproductions. Limit: one (1) PIN per Essay request.

HOW TO PLAY: During the Contest Period, you can play the Lite League game (the “**Game**”) by visiting liteleague.ca and entering your mobile phone number along with the PIN on the card. Once PIN has been submitted, a participant will receive 200 points which equals to one (1) entry into the Grand Prize draw. **BONUS ENTRIES:** For additional Bonus entries, once a participant is registered, a participant may choose a football game on football game days (a “**Match**”) to make his/her predictions on. Each participant will be given a total of sixteen (16) questions and a participant must provide their answer to each question.

Limit: one (1) participation per person/mobile phone number per game and game night, and seven (7) participations per person/mobile phone number per week. For greater certainty and to avoid any doubt, you may only use one (1) mobile phone number to participate in the Contest.

The Organizer/Sponsor assumes no responsibility for the cancellation, delay, suspension or postponement of a Match. In the event of the cancellation of a Match, points awarded in connection with this Match will be forfeited. Each entrant acknowledges that the conduct of the Match is beyond the control of the Organizer/Sponsor.

The entrants must submit each Entry personally. Entries will be deemed to have been submitted by the Authorized Email Account Holder. “**Authorized Email Account Holder**” of an email address means the physical person to whom the email address has been assigned by the Internet access provider, online service provider or other company responsible for the assignment of the e-mail address account. The eligible winner of a Prize (as such term is defined below) may be required to provide proof of being the Authorized Email Account Holder of the email account associated with the email address. By submitting an email address, you represent and warrant that you are the Authorized Email Account Holder. You will be liable to the Sponsor for all damages and other losses suffered by it as a result of your submission of any email address for which you are not the Authorized Email Account Holder. Sponsor reserves the right to: (i) request, at any time, from any entrant, documents proving that they are the Authorized Email Account Holder; and (ii) suspend any entrant, at any time, until such evidence can be provided.

Any attempt by an entrant to obtain more than the specified number of Entries, by using multiple or different email addresses, identities, or any other method will result in the cancellation of that entrant's Entries, and that entrant may be disqualified at the Sponsor's/Organizer's sole discretion. Use of any automated system (including, but not limited to, Entries submitted by means of robots, scripts, macro commands or other automated service) to enter the Contest is prohibited and will result in the entrant's disqualification.

5. **PRIZES.** The following Prizes are available to be won:

(1) **Weekly Prizes:** The following weekly prizes (each a “**Weekly Prize**” and collectively, the “**Weekly Prizes**”) are available to be won during the Contest Period (as such term is defined below) in accordance with section 7(1) below:

Odds of winning a Weekly Prize depend on the number of eligible entries received during the Week immediately preceding each Weekly Prize Draw (as such term is defined below). Weekly Prizes will be awarded on a random basis. Winners may not request a specific Prize. The number of Weekly Prizes available to be won will diminish as Prizes are claimed throughout the Contest.

- (2) **Grand Prizes:** There are two (2) grand prizes (each a "Grand Prize") available to be won throughout the Contest. Each Grand Prize consists of a Miller Lite football experience for the winner and one (1) guest. Specifically, each Grand Prize includes: (i) two (2) round-trip economy class airline tickets or two (2) round-trip economy class train tickets or shuttle tickets (depending on the distance between the winner's residence and the event location) departing from the major Canadian airport, train station, or shuttle station closest to the winner's residence to the selected city (each, a "Trip"); (ii) one (1) night of standard hotel accommodation (double occupancy) (or two (2) nights of standard hotel accommodation, if applicable) near the event location; (iii) two (2) tickets to a football experience in a city selected by Sponsor (the "Event"). Once the itinerary has been finalized between the winner and Sponsor, no changes can be made unless approved by Sponsor. The approximate value of a Grand Prize is: \$5,000.00 CAD (based on sample Toronto departure). The actual value of the Grand Prize will depend on location of winner's residence to the selected city. Winner is not entitled to any monetary difference between the actual and stated value, if any.

The Grand Prize winner and his/her guest shall be responsible for all costs or expenses not specifically described above as included in the Grand Prize, including, but not limited to, ground transportation to and from the winner's residence and the departure airport, train, or shuttle station, any additional transportation, travel and/or medical insurance, meals, beverages, tips, taxes, airport improvement fees, and all incidental and personal expenses. The Grand Prize winner will need to use a credit card upon hotel check-in to cover any incidental charges not specified as included in the Grand Prize. Grand Prize winner and their guest must travel together from the same airport at the required times and dates; otherwise, the Grand Prize will be forfeited. All travel arrangements, accommodations, and the scheduled Event will be organized by Sponsor in its sole discretion. Grand Prize winner and his/her guest must follow all instructions given by the Sponsor and/or Event organizers; failure to do so may result in termination of their participation, or continued participation, in the Grand Prize and/or Event.

It is the sole responsibility of the Grand Prize winner and his/her guest to obtain all required travel documents, including a valid passport (or visa, if applicable). The Grand Prize winner's guest must be twenty-one (21) years of age or older, and the Grand Prize winner and his/her guest must not have any legal restrictions which would prevent them from travelling to the United States or otherwise participating in the Trip(s). Sponsor will not be responsible if the Grand Prize winner and/or his/her

guest are denied entry to the United States or re-entry to Canada. In such a case, the Grand Prize winner and/or his/her guest will be solely responsible for all incurred costs, and the Grand Prize will be forfeited. Grand Prizewinner and his/her guest will not be allowed to enter any authorized area unless they can present valid identification to verify proof of legal drinking age (21 years or older) in the applicable state.

The Weekly Prizes and the Grand Prizes are each a “**Prize**” and collectively, the “**Prizes**.”

Prizes are not transferable or assignable and must be accepted as awarded with no substitutions in cash or otherwise, except at Sponsor’s sole discretion. Sponsor reserves the right, in its sole discretion to substitute a Prize of equivalent monetary value, if a Prize or any part of the Prize, cannot be awarded as described for any reason. The Releasees (as defined below) will not be responsible, however, if weather conditions, Event cancellations, or other factors beyond Sponsor’s reasonable control prevent a Prize or any part of a Prize from being fulfilled. In any such event, winner will not be provided with a substitute Prize or cash equivalent. Prizes will only be released to the verified winners. Limit: one (1) Grand Prize per household.

6. **SELECTION AND NOTIFICATION.** For the purposes of this Contest, a “**Day**” shall mean a calendar day that begins at 12:00:00 a.m. ET and ends at 11:59:59 p.m. ET and a “**Week**” shall begin on Monday at 12:00:00 a.m. ET and end on Sunday at 11:59:59 p.m. ET.

(1) Weekly Prizes

The Weekly Prize Draws will be initiated by a Contest administrator (human) and processed by an algorithm (computer program) that simulates a random draw (a “**Random Draw**”). Any attempt to manipulate or tamper with the winner selection system or the database of Entries will result in disqualification and possible criminal prosecution.

Each week during the Contest Period, 41 entries will be randomly drawn from among all eligible entries received during that Week according to the below schedule except for last week, whereby all remaining xx Weekly Prizes will be drawn. :

Limit: one (1) Weekly Prize per entrant and household for the Contest Period. Unselected Entries for a particular Week will roll over into subsequent Weekly Prize Draws.

Sponsor or its designated representative will make up to three (3) attempts to contact the selected entrants by email to the email submitted at the time of entry within five (5) business days following the Weekly Prize Draw. If the selected entrant: (i) cannot be contacted within three (3) attempts or five (5) business days of being selected (whichever occurs first); or (ii) there is a return of any notification as undeliverable, then the selected entrant will be disqualified and an alternate entrant will be randomly selected from among the remaining eligible Entries received. If time permits, the process noted above will be repeated up to three (3) times, until a selected entrant has been contacted and the Weekly Prize has been awarded or there are no eligible entries remaining.

(2) Grand Prizes

7. PRIZE AWARDING CONDITIONS.

To be declared a winner and be awarded a Weekly Prize or Grand Prize, the selected entrant must: (i) respond to the selection notification within the time period described above; (ii) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question administered at a mutually agreed upon time; and (iii) otherwise comply with these Rules. As a condition of being declared a winner, the selected entrant may also be required to do any or all of the following: (i) supply proof of age consisting of a legible photocopy of either a provincially issued driver's license or other government-issued identification; (ii) supply proof of address consisting of a legible photocopy of either a provincially issued driver's license or other government issued identification, (iii) supply proof that they are the Authorized Email Account Holder associated with the selected email address, and (iv) sign and return the Organizer's Declaration and Release Form (the "**Release Form**"). The Release Form (among other things): (i) confirms compliance with these Rules and acceptance of the applicable Prize as awarded without substitution; (ii) releases the Organizer/Sponsor, and each of its respective affiliated and related companies, the prize suppliers, advertising and promotional agencies and each of their respective shareholders, directors, officers, employees, agents, dealers, representatives, successors and assigns from any liability in connection with this Contest, the selected entrant's participation therein and/or the awarding and use/misuse of the Prize or any portion thereof; and (iii) confirms that the winner agrees to the publication, reproduction and/or other use of his/her name, address, voice, statements about the Contest and/or photograph or other likeness, without further notice or compensation, in any publicity or advertisement carried out by the Organizer in any manner whatsoever, including print, broadcast or the Internet. Grand Prize winner's guest must also sign and return a Release form. The Release Form must be received by the Sponsor within the time period indicated on the Release Forms. Sponsor and its agents assume no responsibility for lost, stolen, delayed, illegible, damaged, misdirected, late, or otherwise void Release Forms.

Declining the Prize, failing to correctly answer the mathematical skill-testing question, failing to return the properly executed Release Form within the time period indicated on the Release Form or otherwise failing to comply with these Rules will cause the Prize to be forfeited and Sponsor reserves the right if time permitting to select an alternate eligible entrant in accordance with the process for the applicable Prize, as described above.

In most cases, Prizes will be delivered to winners at the address submitted in the Release Form within six (6) to eight (8) weeks of receiving their correctly completed documentation. Sponsor is not responsible for contacting or forwarding Prizes to winners who leave unclear or incomplete information or for Prizes lost, misdirected, delayed or destroyed while in transit.

By accepting a Prize, the winners consent to the collection, use and disclosure to the public of their names, addresses (city, province/territory), voices, statements and photographs or other likenesses for publicity purposes in connection with the Contest in any media or formats, including but not limited to the Internet, without further notice, permission or compensation. Personal information will not otherwise be used or disclosed without consent. This section does not limit any other consent(s) that an individual may provide the Sponsor or others in relation to the collection, use and/or disclosure of their personal information.

10. **RIGHT TO MODIFY, CANCEL, SUSPEND, TERMINATE.** Sponsor and its authorized representatives reserve the right, at their sole discretion, and without notice, to cancel, suspend or modify the Contest, in whole or in part, or the entrants' eligibility for any reason whatsoever, including, but not limited to, printing errors, administrative errors, viruses, bugs, unauthorized human intervention, tampering, fraud, equipment failure, security breach or other causes that corrupt or affect the administration, security, fairness or proper conduct of the Contest.

In the event of the postponement or cancellation of the regular season or one or more Matches, the Sponsor and its authorized representatives reserve the right, at their sole discretion, to cancel, suspend or modify the Contest, in whole or in part.

- 11. GENERAL CONDITIONS.** All decisions of the Sponsor, or any contest judging organization as designated by them, are final and binding without right of appeal in all matters relating to this Contest and by entering this Contest, all entrants agree to be bound by these Official Contest Rules. The Releasees will not be responsible for illegible, incomplete, lost, postage-due, misdirected, affected by technical failures, errors or late PIN entries which will be void. Any use of automated devices is prohibited. All PIN entries become the property of Sponsor and will not be acknowledged or returned. No correspondence will be entered into except with selected entrants (or any other entrant(s) as deemed necessary by the Sponsor). Contest is subject to all applicable federal, provincial and municipal laws. In the event of a dispute regarding who submitted an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. An entrant may be required to provide Sponsor with proof (in a form acceptable to the Sponsor – including, without limitation, government-issued photo identification) that he/she is the authorized account holder of the e-mail address associated with the entry in question.

Sponsor reserves the right at its sole discretion to disqualify, from this Contest and any future Contest or other promotion conducted by Sponsor, any individual that it finds or believes to be not in compliance with these Official Contest Rules; to be tampering with the entry process or the operation of the Contest or Contest Website; or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. ANY ATTEMPT BY AN ENTRANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE ANY WEBSITE OR TO UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND, SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. Subject only to applicable law and any required regulatory approval, the Sponsor reserves the right and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Official Contest Rules, to the extent necessary, for purposes of verifying compliance by any entrant or entry with these Official Contest Rules, or as a result of any technical or other problems, or in light of any other circumstances which, in the opinion of the Sponsor affects the proper administration of the Contest as contemplated in these Official Contest Rules, or for any other reason.

In the event of any discrepancy or inconsistency between the terms and conditions of these English Official Contest Rules and disclosures or other statements contained in any Contest-related materials, the terms and conditions of these English Official Contest Rules shall prevail, govern and control to the fullest extent permitted by applicable law.

LIQUOR AUTHORITIES: The provincial liquor authorities are not connected with this Contest in any manner whatsoever and are not liable in any way whatsoever with regards to any matter relating to this Contest.
